| Kosten                   | Counselling and support at the youth welfare office,<br>including in the form of guardianship, is free of charge.  |
| Verfahrensablauf         | If you have become a mother and are not married, you<br>will receive an offer of support from the Youth Welfare<br>Office immediately after the birth. This offer concerns<br>the establishment of paternity and the assertion of<br>child maintenance claims. |

The application for assistance must be made in writing.

|                                 | Although this can be replaced by electronic form, you<br>will need a qualified electronic signature for this.<br>Discuss the application with the future guardian<br>beforehand.   |
|                                 | The guardianship begins as soon as your application<br>has been received by the youth welfare office. You will<br>not receive a confirmation.  |
|                                 | The guardianship ends at the latest when the child<br>reaches the age of majority. You can terminate it in<br>writing at any time and apply for it again at any time.<br>The guardianship also ends if the child usually lives<br>abroad.  |
|                                 | You can limit it at any time, even retrospectively, to individual tasks, for example establishing paternity.   |
|                                 | When establishing paternity, the guardian first contacts<br>the alleged father. If paternity is not recognised, he or<br>she applies to the competent family court on behalf of<br>the child to establish paternity.   |
|                                 | When asserting maintenance claims for the child, the<br>legal adviser asks the parent liable for maintenance to<br>provide information on his or her income and financial<br>circumstances and to voluntarily recognise the<br>maintenance claim subsequently calculated by the<br>legal adviser in the form of an enforceable deed. If the<br>parent refuses to recognise the claim, for example<br>because they consider the calculation to be incorrect,<br>court proceedings will ensue. |
