- Parking in designated traffic-calmed areas outside the marked parking bays, if you do not exceed the parking space limitbtraffic (especially moving traffic) if you do not obstruct other trafficnproportionately interfere with other traffic

The maximum permitted parking time of 24 hours must not be exceeded.

Please note: You are not allowed to park in car parks with the wheelchair symbol if you have an "orange parking permit". Parking permits ("blue parking permit") for these car parksare only issued to

- severely disabled people with exceptional walking disabilities (§ 229 Para. 3 SGB IX), bilateral amelia or phocomelia or verequivalent functional restrictions and
- · blind people.

Erforderliche Unterlagen

- · Severely disabled person's pass
- for renewal: additional old parking permit

Voraussetzungen

You can obtain the "orange-coloured parking permit" if one of these cases applies to you:

- You are severely disabled with the G and B signs and a GdB of at least 70 for functional disorders of the lower limbs alone (and the lumbar spine, insofar as these affect the ability to walk) and at the same time a GdB of at least 50 for functional disorders of the heart or respiratory organs.
- You suffer from Crohn's disease or ulcerative colitis and the GdB determined for this is at least 60.
- You have an artificial anus and at the same time an artificial urinary diversion and the GdB determined for this is at least 70.
- You are severely disabled and, according to a medical assessment, are to be treated in the same way as the aforementioned group of people.

	Please note: The decisive factor is the individual GdB for the respective functional impairment and not the total GdB resulting from the sum of individual functional impairments.
Kosten	usually none
Verfahrensablauf	You must apply for the "orange-coloured parking permit" in writing to the road traffic authority. You can obtain the form there. Depending on the services offered by your local road traffic authority, you can also download it from the Internet. The road traffic authority will forward your application to the internalüto the pension administration. There, the medical service will check whether you fulfil the eligibility requirements. The basis for the decision is the severely disabled person'skand the findings and
	assessments contained therein.
	If you fulfil the requirements, you will usually receive the "orange-coloured parking permit" for five years. After that, you can apply for an extension.
	If your application is rejected, you can appeal to the road traffic authorityeauthority against the decision.
