(Continuation assistance and aftercare also possible for over 21s)</li> <li>The help is necessary because of your individual situation.</li> <li>If you have already received child and youth welfare services before your 18th birthday, the help for young adults is intended to prevent the help from suddenly stopping when you reach the age of majority.</li> </ul>            |
| Kosten                          | Depending on the form of the assistance, you may be able to share in the costs.   |
| Verfahrensablauf                | Contact the responsible youth welfare office. The<br>Youth Welfare Office decides whether a claim exists<br>and helps with the application for assistance.<br>If the assistance is granted, all those involved draw up<br>an assistance plan together. This plan specifies the<br>course of action, the goals and the duration of the<br>help.<br>The Youth Welfare Office reviews the progress of the<br>help in regular meetings. |
