	<p>demand planning.</p> <p>In open planning areas, you can set up a new practice, take over an existing practice or join a group practice. In the blocked planning area, a colleague must first hand over a suitable seat, which you can take over in the back-filling procedure.</p>
Kosten	<ul style="list-style-type: none"> • Application for admission: EUR 100.00 • if the notice of admission has become final: EUR 400.00
Verfahrensablauf	<p>You must apply for admission in writing. You can obtain application forms from the offices of the admissions committees.</p> <p>The admissions committee decides on your application after an oral hearing. You will then be informed of the decision in writing.</p>

Frist	Submit the application approximately twelve to no later than four weeks before the meeting date of the competent admission committee.

Hinweise	If you are planning to set up a practice in a restricted planning area, have yourself entered on the free waiting list of the Association of Statutory Health Insurance Physicians as early as possible.
Rechtsbehelf	You can lodge an appeal against the decision of the admissions committee in writing or in writing with the office of the competent appeal committee.
