| Teaser | You may only work as a vet in Baden-Württemberg if you have obtained a German licence or you are in possession of a temporary or restricted permit to work in the veterinary profession. |
| Volltext | <p>You may only work as a vet in Baden-Württemberg if you have obtained a German licence or you are in possession of a temporary or restricted permit to work in the veterinary profession. On commencement of work as a vet, in accordance with the law you are a member of the State Professional Body of Vets of Baden-Württemberg.</p> <p>The main duties of the chamber are, amongst other things, to look after the professional interests of the members, to promote further and advanced training and to monitor compliance with professional obligations.</p> <p>You must pay an annual fee as a member. This is gathered by the Body in order to cover its expenses. For the first year following the obtaining of the licence or professional permit, you are exempted from payment of the fee.</p> <p>Note: Should you move your activities as a vet or your place of residence (without being employed as a vet) abroad, you can remain as a voluntary member.</p> |

The Federal Chamber of Veterinary Surgeons can request that the original documents be presented.</p> |
| Voraussetzungen | <p>You must:</p> <ul style="list-style-type: none"> • be a vet, • possess a German license or have a temporary or restricted licence to work as a vet (in Baden-Württemberg, this is issued by the Regional Council of Stuttgart) and • work as a veterinary surgeon in Baden-Württemberg or, if you do not exercise your profession, be resident in Baden-Württemberg. |

| Verfahrensablauf | <p>Please contact the administrative office of the State Professional Body of Vets in advance by telephone, email or fax This will then send you the registration documents by post. Alongside the registration forms, you will also receive the code of conduct of the Body and information brochures. The registration forms are not available for downloading.</p> |
| Bearbeitungsdauer | <p>The processing time depends on full submission of the required documents.</p> |
| Frist | <p>You must register with the competent authority within one month of starting work as a veterinary surgeon in Baden-Württemberg or of registering as a resident of Baden-Württemberg.</p> |
