On Shrove Tuesday night and 1 May it starts at 5 am. This does not apply to gambling halls. 	• revoked. Note: The authority may impose conditions at any time when shortening or lifting the closing time. Under certain conditions, the authorities may also generally extend, shorten or abolish the curfew by ordinance. Indicate, • in what form and • reasons why you want to shorten the closing time. Depending on what the municipality offers, an application form is available or you can download it from the internet.
