| Voraussetzungen | The competent authority must grant the licence if no facts are known that give rise to concerns about the reliability of the proprietor or the persons responsible for the management and supervision of the establishment, and the proprietor, insofar as he is responsible for the performance of the establishment, the persons responsible for the management and supervision of the establishment and the other personnel have the necessary technical and professional expertise for their activities. |
