If you wish to carry out fumigation on a commercial basis or independently as part of other economic activities, you must apply for a licence from the competent authority. If your application is successful, you will be granted a licence to carry out fumigation.
Erforderliche Unterlagen	The following information is required to apply for a licence: • Information on the spatial and safety-related equipment, • Proof of compliance with the relevant occupational health and safety regulations, including risk assessments and operating instructions, • Name and authorisation or registration number of the biocidal product or plant protection product and its type of use, • Copies of the certificates of competence of the holders of the certificates of competence, • Copies of the certificates of competence of the authorised persons.
Voraussetzungen	The prerequisite is that you fulfil the personnel, spatial and safety requirements.
