respective municipality.
 They take into account, among other things

- The type and extent of the impact on the road and
- the economic interest of the applicant.

Verfahrensablauf

You must apply for the special use permit at the responsible office.
 Use the application form provided for this purpose.
 You can obtain it from the competent authority or, depending on the offer, it can be downloaded from the internet.

The competent authority primarily checks what effects a permit would have on the use of the road.

The intended special use must not

- interfere too much with the public use of others,
- Cause a noise nuisance to pedestrians or anyone living in the street (residents),
- excessively pollute the street; or
- adversely affect the townscape

After your application has been assessed, you will receive a notice of approval or a notice of refusal.

The competent authority limits the permit in time or grants it revocably.
 It may attach conditions and requirements.
