Voraussetzungen	You can receive benefits from the Landesstiftung if • Your family is in need, • there are no other possibilities for help (e.g. advance maintenance payments, social assistance) or existing possibilities are not sufficient, • the emergency situation can be overcome permanently with the help of the foundation and • You as the applicant have your permanent residence in Baden-Württemberg.

Verfahrensablauf	Arrange a meeting with the relevant counselling centre. During this meeting, the advice centre will complete the application to the Landesstiftung together with you. It will then forward the application to the award committee at the Baden-Württemberg Municipal Association for Youth and Social Affairs. The committee makes the final decision on the application. If the decision is favourable, you will receive a notification from L-Bank. If the Kommunalverband für Jugend und Soziales Baden-Württemberg rejects your application, you will receive notification from them.
