Volltext	<p>The ID card authority will inform you as soon as the ID card can be collected.</p> <p>After applying for an ID card, Bundesdruckerei GmbH is commissioned by the ID card authority to issue the ID card. The processing time is approximately 4 to 6 weeks. Once the ID card has been completed by Bundesdruckerei, the applicant receives a PIN letter from Bundesdruckerei informing them that the ID card will be ready for collection shortly. As a rule, the applicant can then collect their ID card from the ID card authority within the next few days.</p>
