Teaser	You can apply for an extract from the real estate register. The real estate cadastre contains factual information on the parcel (e.g. parcel number, size of the parcel, types of use, etc.) and personal data (e.g. owner of the parcel).
Volltext	You can apply for an extract from the real estate register. The real estate cadastre contains factual information on the parcel (such as the parcel number, size of the parcel, types of use, yield measurement figures) and personal data (such as the owner of the parcel, corresponding land register sheet number). These are provided in various extracts as required. You can apply for parcel certificates with and without land valuation data, parcel and owner certificates with and without land valuation data, property certificates and inventory certificates. If you wish to obtain a parcel certificate without personal data, you can do so via the GeoShops of the districts and independent cities.
Erforderliche Unterlagen	• if applicable, a power of attorney for the verification of the legitimate interest • if applicable, the power of representation for a legal entity • if applicable, proof of the applicant's legitimate interest
Voraussetzungen	• Proof of legitimate interest in knowing the personal data of the land parcel certificate

Verfahrensablauf	Apply in writing to the relevant lower surveying and geoinformation authority (land registry office) for a parcel and ownership certificate. Prove that you have a legitimate interest in knowing the personal data contained in the extract. Whether your interest is justified will be checked. If the check is positive, the requested extract will be sent to you by post. You then pay the fee for the process. If you wish to apply for a parcel certificate without personal data, you can order this online in the GeoShop of the responsible lower surveying and geoinformation authority. Hinweise	If you wish to reproduce, process, convert, pass on to third parties or publish the extract from the real estate cadastre, you require the consent of the responsible surveying and geoinformation authority.
