Volltext	<p>An additional permit (driver's license for passenger transport) is required for anyone who drives an ambulance if passengers are transported in the vehicle for payment or on a business basis, or anyone who drives a motor vehicle if passengers are transported in the vehicle and a permit is required for this transport in accordance with the Passenger Transport Act.</p> <p>If you want to drive cabs, rental cars, ambulances for the paid transportation of passengers or drive passenger vehicles in regular service and for excursions and vacation destination trips, you need a separate driver's license for passenger transportation in addition to your driver's license. The passenger transport license is issued for a period not exceeding five years. It will be extended for up to five years at a time upon application by the holder if he or she proves his or her mental and physical aptitude in accordance with Section 11, Paragraph 9 of the FeV in conjunction with Appendix 5 to the FeV by means of an expert opinion when the license is first issued. The expert opinion is to be conducted in compliance with the principles set out in Annex 4a FeV by providing an occupational or occupational medical opinion in accordance with Section 11 (2) sentence 3 number 3 FeV or an expert opinion from an officially recognized assessment center for driving aptitude. The expert opinion does not have to be repeated for each five-year extension of the driving license. If the driver's license is renewed beyond the age of 60, he or she must provide a current occupational or occupational medical report or a report from an officially recognized assessment center for driving aptitude. In addition, the driver must prove that he or she meets the</p>

requirements for eyesight pursuant to Section 12, Paragraph 6 of the FeV in conjunction with Appendix 6, Number 2 of the FeV and that there is nothing against him or her to indicate that he or she does not meet the special responsibilities involved in transporting passengers (by submitting a certificate of good conduct and information from the driver suitability register). Likewise, there must be no fines for violations of the BOKraft or the Passenger Transportation Act.

A driver's license for passenger transport, on the other hand, is not required for:

- Ambulances of the Federal Armed Forces, the Federal Border Guard, the police, as well as for troops and civilian entourages of other NATO contracting states.
- ambulances of the civil protection, if they are used for this purpose
- ambulances of fire departments and rescue services recognized by state law
- motor vehicles, with the exception of cabs or rental cars, if the driver is in possession of a class D or D1 license
- transports listed in the exemption regulation.

Erforderliche Unterlagen

- valid identity card or valid passport with current certificate of residence,
- Proof of the previous domestic driving license (driver's license), if necessary the exchange into an EU-card driver's license has to be applied for
- Proof that the applicant has held an EU or EEA Class B driving license or a corresponding foreign driving license for at least two years - or at least one year if the license is restricted to ambulances - or has held it within the last five years,
- a certificate of the applicant's medical examination; general practitioners usually have the appropriate form ready,
- a current certificate of the applicant's ophthalmological examination; ophthalmologists usually have the appropriate form available,
- if the driver's license to carry passengers is extended beyond the age of 60, the applicant must also submit an occupational health certificate or a certificate from an officially recognized assessment center for driving aptitude with regard to the applicant's ability to cope with stress, orientation, concentration, attention and

reaction times,

- if the driver's license for passenger transport is to be valid for ambulances, additional proof of the applicant's participation in first aid training,
- current certificate of good conduct of type "0" (official certificate of good conduct, which can be applied for at the Federal Office of Justice via the municipality of residence. A private certificate of good conduct is not sufficient.

Voraussetzungen

You have held the EU or EEA driving license required for driving the vehicle or a corresponding foreign driving license for at least two years or have held it for the last five years. If the driving license is restricted to ambulances, you have held the driving license required for driving the vehicle for at least one year.

You are at least 21 years old. If the driver's license is restricted to passenger transport for ambulances, your minimum age is 19 years.

A certificate of good conduct is already available or has been applied for by you.

You have a medical certificate confirming your mental and physical fitness.

You have a certificate from an ophthalmologist confirming your eyesight.

You have an EU or EEA class B driver's license or equivalent.

If the permit is to be valid for ambulances, proof of your participation in first aid training is available.

If you are to be issued a cab driver's license, you must provide proof that you have the necessary local knowledge in the area where you are required to drive or in the place where you have your registered office.

Kosten

Fees and expenses are incurred, the amount of which is determined by the administrative expense, which are laid down in the schedule of fees for road traffic measures and are set by the driving license authority. Please contact the responsible office.

This does not include the costs for the extract from the Federal Central Register and for medical certificates or expert reports.

Verfahrensablauf

Responsibility lies with the county, independent city or large city in which you reside. A personal appearance

at the locally responsible driver's license authority is required, as signatures must be provided. Applying through a representative is not possible. The driver's license authority will query your score at the Federal Motor Transport Authority (KBA). If you meet all the requirements positively, the driving license authority will grant you as an applicant the driving license for passenger transport for a period not exceeding five years.

four to six weeks, provided that all documents are available

Frist

The driver's license for passenger transport is issued for a period not exceeding five years. It is renewed on application for up to five years at a time if the holder • proves his mental and physical fitness, • proves that he meets the requirements for eyesight, and • submits a certificate of good conduct.

Anyone who transports passengers in an ambulance for pay or on business, or transports passengers in a vehicle and requires a permit under the Passenger Transportation Act for such transportation, must have a driver's license to transport passengers (additional permit).

In Mecklenburg-Western Pomerania, the driving license authorities are the district councils, the mayors of the independent cities and the large cities belonging to the district. The local authority responsible is the authority of the place where the person concerned has his/her residence, or his/her main residence if there are several residences; in the absence of such a residence, the authority of the place of residence is responsible.
