Volltext	<p>On Sundays and public holidays, trucks with a maximum permissible mass exceeding 7.5 t and trailers behind trucks are not allowed to drive between 0:00 and 22:00. This ban does not apply to certain goods (e.g. various perishable foodstuffs).</p> <p>Furthermore, an exemption may be granted under certain conditions, e.g. for:</p> <ul style="list-style-type: none"> • live animals • cut flowers and live plants • agricultural products in their harvest season, if they are not already exempted • equipment, exhibits and foodstuffs for fairs, exhibitions, markets, public festivals, cultural or sporting events • Trips by vintage trucks to trade fairs, exhibitions, markets, public festivals, cultural or sporting events • Newspapers and magazines with publication dates on Sundays or holidays or on the following day • Goods for the timely loading or unloading of sea-going vessels or aircraft, provided that it is proven that the use of a specific ship or air connection or a direct connecting transport by road on Sundays or holidays is urgently required for reasons of general welfare or in the interest of the applicant

Erforderliche Unterlagen	<ul style="list-style-type: none"> • Written application with reasons, in particular the urgency, and a proof of the necessity of the transport during the prohibition period with the requested means of transport. • if a permanent exemption permit is applied for, proof of the necessity of regular transport during the ban period, e.g. a certificate of urgency issued by the Chamber of Industry and Commerce • the motor vehicle registration certificate or the registration certificate part 1; for foreign vehicles in whose registration documents the permissible total mass is not entered, a corresponding official certificate • in the case of loading and unloading of sea-going vessels and aircraft, as well as journeys where urgency must first be checked: Proof of the necessity of transport during the period of prohibition with the requested means of transport.
