Volltext	If the basic features of the intended urban development in a municipality are to be changed on a large scale and considerable effects are to be expected and re-evaluated as a result of the new spatial allocation of the various types of land use, the existing land use plan is to be cancelled by the municipality. However, the complete repeal of the land use plan is extremely rarely practiced because it means that the basis for the development of land use plans no longer exists. As a rule, land use plans are amended or supplemented if a few or several changes of a manageable scope are involved.
Erforderliche Unterlagen	land-use plan to be repealed and justified with information in accordance with Section 2a bauGB (environmental report)
Voraussetzungen	The procedure prescribed by the legislator must be followed (sh. procedure).
Kosten	The costs of canceling a land-use plan are to be borne by the municipality.
Verfahrensablauf	1. resolution on the cancellation of the land use plan
Bearbeitungsdauer	Duration of the proceedings depends on the complexity of the effects of the repeal.
Frist	The date of the early public participation and the one-month public display of the land use plan documents, which can be seen from the local announcement, must be observed.
