Volltext	Citizens have the opportunity to comment on and discuss the land use plan during the early public participation period. During the subsequent one-month public display, there is the opportunity to obtain information on the intended urban development and to submit comments. Once the land use plan has been published, citizens can obtain information at any time.
Erforderliche Unterlagen	Land use plan and explanatory statement with information in accordance with Section 2a BauGB (environmental report)
Voraussetzungen	The procedure stipulated by law must be followed (see procedure).
Kosten	The costs for the land use plan are to be borne by the municipality.
Verfahrensablauf	1. resolution on the preparation of the land use plan
Bearbeitungsdauer	depending on the complexity of the request for information
Frist	Citizens must pay attention to the date of the early public participation and the date of the public display of the land use plan. Both dates will be announced in the usual manner.
