Volltext	<p>The state grants subsidies for measures that serve to safeguard, preserve and restore architectural monuments, movable monuments and ground monuments.</p> <p>Monument protection and preservation are the responsibility of the state, districts and municipalities. The specialist authority is the State Office for Culture and Monument Preservation. It advises and supports the monument protection authorities in the preservation and protection of monuments. It is the duty of every monument owner to preserve and maintain the monument. To this end, a monument preservation objective confirmed by the specialist authority can be used. It essentially comprises an analysis of the existing building, a description of</p>

planned conservation measures and their implementation. Every monument owner is entitled to the legally regulated tax relief if they maintain and use their monument in consultation with the relevant authorities.

For the protection, preservation, restoration and partial reconstruction of monuments, it is possible to apply for state funding from the State Office for Culture and Monument Preservation. The subject of the funding is always the additional costs incurred as a result of the monument. The monument preservation objective confirmed by the specialist authority is part of an application for the approval of financial grants for the preservation of the monument.

**Erforderliche Unterlagen**

- Fully completed and signed application form
- Detailed cost estimate from an engineering/architectural office or submission of at least three comparable offers
- Meaningful, detailed damage documentation
- current extract from the land register
- Site plan/city map with identification of parcel/plot
- Planning drawings/floor plans, if applicable
- Required permits (listed building permit/building permit)
- Confirmed monument preservation objectives
- Authorization to represent, if applicable

**Voraussetzungen**

- the property must be a listed building
- The applicant must be the owner, possessor or maintenance beneficiary
- The measure must not have been started yet

It must involve work to secure, preserve and restore monuments in their original state

**Kosten**

- The grant is awarded as a non-repayable subsidy
- up to 50% of the eligible costs
- Application and notification are processed and issued free of charge

<b>Frist</b>	The application for funding for monument preservation measures should be submitted by October 31 of each year for the following year. be submitted.

<b>Hinweise</b>	<p>The information on which the granting, reclaiming and retention of the grant depend are subsidy-relevant facts within the meaning of Section 264 of the German Criminal Code in conjunction with the Act against Abusive Use of Subsidies of July 12, 1995 (GVOBI. M-V p. 330).</p> <p>Anyone who provides false or incomplete information or conceals facts relevant to the subsidy is liable to prosecution.</p> <p>The public procurement regulations must be applied (VOB, VOL, VgV, GWB etc.).</p> <p>The currently valid value limit decree must be observed.</p>
<b>Rechtsbehelf</b>	The applicant is not entitled to the grant. The granting authority decides on the basis of its dutiful discretion within the framework of the available budget funds.
