Especially in people with a handicap, sporting activities have a serious significance. They maintain and increase performance, promote self-confidence, strengthen self-confidence and thus provide effective life support. The Association for Disabled and Rehabilitation Sports M-V e. V. (VBRS M-V) as a sports federation in close cooperation with the state government, is focused and consistent on current social and political developments in sport with a handicap at the state level. In particular, exercise, sport and play are used as an accompanying means for improving, maintaining or regaining health, as well as for strengthening self-initiative and independence within the framework of social integration/inclusion and equal participation. The VBRS M-V advises citizens on the possibilities of physically active activity with a handicap in the leisure, wide and performance range and offers opportunities nationwide to become active in one of the currently 105 sports clubs themselves.
