Bearbeitungsdauer	Generally 14 days upon submission of all necessary documents. At the time of publication, the conversion reports have not yet been published. As soon as these have been published as NfL, the license can be converted.
Frist	The updated conversion reports are valid indefinitely.

Hinweise	Aeronautical inspections/checks are based on the specifications of the conversion report.
