The costs of procurement, installation, removal and maintenance as well as the operation of the official traffic signs and traffic facilities are generally borne by the road construction authority for the road along which they are installed.

For freeways and branching roads, this is the State Office for Road Construction and Traffic, for federal and state roads it is the road construction offices in

Neustrelitz, Schwerin and Stralsund. The districts, municipalities and cities are responsible for the construction of the district and municipal roads on their territory.

Further information can be found in the StVO and, with regard to the cost regulation, in § 5b Road Traffic Act (StVG).
