Cybercrime is all criminal acts that are directed against the Internet, data networks, IT systems and their data, or that are committed by means of IT, for example: • Data/identity theft, • data theft, • online extortion by means of: • DDoS (Distributed Denial of Service) or. • Ransomware/ Crypto Trojan, • Man-in-the-middle attack, and • CEO Fraud. You can also get in touch if you would like advice on cybercrime prevention measures. The ZAC service in the federal state in which your company is located is responsible for you.
