Teaser	You have a right to know that the data a public authority processes about you, for example, is correct. Therefore, request the correction of your data if you notice that incorrect data about you is being processed.
Volltext	The registration office is obliged to correct or complete incorrect or incomplete personal data. If you discover that the registration authority is processing incorrect or incomplete personal data about you, you can informally request that this data be corrected or completed. The authority will then check whether the data is indeed incorrect or incomplete. If this is the case, the data will be corrected or completed.
Erforderliche Unterlagen	In order to prove that the personal data processed are inaccurate or incomplete, documents showing the correct data may have to be provided.
Voraussetzungen	The prerequisites for a correction are, on the one hand, incorrect or incomplete data and, on the other hand, the undoubted determination of the incorrectness or incompleteness. The registration authority must also be aware of the correct data.
Kosten	free of charge
Verfahrensablauf	As soon as you have requested a correction of incorrect personal data and the authority determines that the data is indeed incorrect, the correction will be made insofar as the authority is aware of the correct data.

Modul	Sachverhalt
	You will be informed of the result of the examination of your request for correction. The registration authority will also inform those public bodies to which the incorrect or incomplete data has been transmitted as part of regular data transmissions in accordance with the Federal Registration Act.
Bearbeitungsdauer	Low. In simple cases, the correction is made immediately; however, if necessary, the verification of whether the personal data is actually incorrect and the identification of the correct data takes time.

Kurztext	The correction of personal data may be requested by the data subject from the competent registration authority.
Ansprechpunkt	The responsible registration authorities. In Mecklenburg-Western Pomerania, these are the administrative districts, municipalities with no administrative district, large cities belonging to a district, and cities with no administrative district.
