the immigration authority responsible for your place of residence.

The same conditions apply for the extension as for the issue. This means that you must still be employed as a civil servant by a German employer and wish to stay in Germany to fulfill your official duties.

If your residence permit is extended, it will be limited in time again. The duration of the time limit depends on the planned duration of your employment.

The Federal Employment Agency does not need to be involved in the extension of your residence permit.

You may have been obliged to take part in an integration course when your residence permit was first issued. If this is the case, this must be taken into account when extending your residence permit. If you have not yet taken part in an integration course, the immigration authority may reject your application to extend your residence permit. If you have not yet completed the integration course, the residence permit will generally only be extended for one year at a time until you successfully complete it or provide proof that you have been integrated into society and social life in another way.

If you have been in possession of a residence permit to perform official duties with a German employer for three years, you are entitled to be issued with a permanent residence permit (settlement permit). This is subject to the condition have paid contributions to the statutory pension insurance scheme for at least 60 months or have to provide evidence of expenses for an entitlement to comparable benefits.

### Voraussetzungen

- You have a recognized and valid passport or passport substitute.
- There is no interest in deporting you.
- Your stay does not jeopardize or impair the interests of the Federal Republic of Germany.
- You are employed as a civil servant by a German employer and are expected to fulfill official duties in Germany.

### Kosten

Extension of residence permit:

- for a further stay of up to three months: EUR 96.00
- for a further stay of more than three months: EUR 93.00

Under certain conditions, a fee reduction or fee exemption may be possible.

Note: The residence permit in the form of the electronic residence permit must be reissued for the extension. The fee for reissuing the card body is EUR 67.00.

### Verfahrensablauf

You must apply for an extension of your residence permit at the foreigners authority responsible for your place of residence. The procedure is as follows:

- Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic applications for residence permits. In the case of an electronic application, the foreigners authority will contact you after receiving your application to arrange an appointment at the foreigners authority. Your supporting documents will be checked during the appointment (bring them with you to the appointment).
- If the application can only be submitted in person, make an appointment with the Foreigners' Registration Office. During the appointment, your application will be accepted and your supporting documents will be checked (bring these with you to the appointment).
- Your fingerprints will be taken at the immigration office to renew your electronic residence permit (eAT card).

**Sachverhalt**

- No approval from the Federal Employment Agency required
- If the applicant has already held a residence permit for three years for the purpose of fulfilling official duties in a civil servant relationship with a German employer, they are entitled to a settlement permit under simplified conditions.
- If the obligation to attend an integration course was stated when the residence permit was first issued, proof must be provided that this obligation has been fulfilled. If the integration course has not yet been completed, the immigration authority may refuse to extend the residence permit or only extend it for one year until the course has been successfully completed or proof has been provided that integration into society and social life has taken place in another way.
- An extension is excluded if this was already ruled out by the immigration authority when the permit was issued or when it was last extended.
- Depending on the foreigners authority and your request, the application can be made online or in person.
- Fees are charged for the extension. The time and form of payment vary depending on the authority.
