If you have not yet completed the integration course, your residence permit will generally only be extended for one year at a time until you successfully complete the course or provide proof that you have been integrated into society and social life in another way.
	If your residence permit is extended, it will be limited in time again. The residence permit for the purpose of research will be extended for the duration of the research project. As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.

You can cover your living expenses and health insurance cover from your income without claiming public benefits. If you are required to attend an integration course

Verfahrensablauf	 The extension of your residence permit must be applied for at the foreigners authority responsible for your place of residence. Depending on the foreigners authority and your request, it may be possible to apply online. Find out whether your foreigners authority offers electronic application for a residence permit. If the application can only be made in person, arrange an appointment with the immigration office. During the appointment, your application will be accepted and your supporting documents checked (please bring these with you to the appointment). Your fingerprints will be taken for the issue of the electronic residence permit (eAT). In the case of an electronic application, the Foreigners' Registration Office will contact you after receiving your online application to arrange an appointment) and your fingerprints will be checked (please bring them with you to the appointment, your documents will be checked (please bring them with you to the appointment for an interview at the Foreigners' Registration Office. During the appointment, your documents will be checked (please bring them with you to the appointment) and your fingerprints will be taken for the eAT card to be issued. 	 continued. The extension must be applied for at least eight weeks before the expiry date. An extension of the residence permit for the purpose of research is only possible if the requirements that were met when the permit was first issued are still met. In the course of the extension, the residence permit is again limited in time. If the obligation to attend an integration course was stated when the residence permit was issued, proof must be provided that this obligation has been fulfilled. If the integration course has not yet been completed, the foreigners authority may refuse to extend the residence permit for one year until the course has been successfully completed or proof has been provided that integration into social life has taken place in another way. An extension is excluded if this was already ruled out by the foreigners authority when the permit was issued or when it was last extended. Depending on the foreigners authority and your request, you can apply online or in person. Fees are charged for the extension. The time and form of payment vary depending on the authority responsible for the applicant's place of residence
