| If you want to handle explosive substances in the commercial sector or operate traffic, you need a permit for this in accordance with the Explosives Act.<br>Activities in connection with explosive substances have a great potential for danger. The aim of the Explosives Act is to protect people and property from these dangers.<br>In order to prevent accidents and misuse, the Explosives Act places high demands on the suitability, reliability and expertise of persons who wish to handle explosive substances. Within the scope of reliability, information is obtained from other authorities, e.g. police, public prosecutor's office.<br>If you, as an entrepreneur, wish to handle or deal with the following explosive substances, |

|                          | The official permit ensures that only those persons<br>have access to explosive substances who meet the<br>requirements for safe handling.<br>When applying for a commercial permit, the<br>responsible authority may ask you for further<br>information on the available storage facilities for the<br>explosive substances.  |
| Erforderliche Unterlagen | <ul> <li>Valid identity card or passport</li> <li>Proof of professional competence or proven<br/>competent person (certificate of competence holder)</li> <li>Proof of liability insurance</li> <li>Description of the intended storage (e.g. technical<br/>documentation, photographic evidence, storage plan)</li> <li>Certificate of no objection</li> <li>For the verification of the reliability of persons from<br/>abroad: You will need a certificate in a certified<br/>translation from the competent judicial or<br/>administrative authority in your home country or<br/>country of origin concerning certain facts that are<br/>relevant to the assessment of your reliability (e.g.<br/>criminal record extract).</li> </ul>   |
| Voraussetzungen          | <ul> <li>To obtain a permit to handle and transport explosive substances, you must meet the following requirements:</li> <li>You must have reached the age of 21 to handle explosive substances.</li> <li>You must have a technical qualification. The specialist knowledge is proven by a certificate which attests to successful participation in a state or state-recognized training course.</li> <li>They must be reliable. The required reliability is normally given if you have so far behaved in a law-abiding manner and have no criminal record.</li> <li>You must be personally suitable. You are personally suitable if you have no limitations, e.g. in mental or physical health or due to drug or alcohol addiction.</li> <li>You must have suitable rooms or storage facilities for safekeeping.</li> </ul> |

| Verfahrensablauf                | Before you, as an entrepreneur, are allowed to handle<br>explosive substances or to deal with them, you must<br>have been granted a permit in accordance with § 7 of<br>the Explosives Act.  |
|                                 | To obtain the permit, you must submit an application<br>and all the necessary documents. The documents will<br>then be checked by the responsible authority. If there<br>are any questions or uncertainties, the authority will<br>contact you and, if necessary, invite you to a personal<br>interview.   |
|                                 | After the documents have been checked, you will receive a notification of the decision and a fee notice with a request for payment.  |
| Bearbeitungsdauer               |  |
| Frist                           | Deadlines for subsequent submissions/returns are set<br>by the competent authority. If you already have a<br>permit, you must submit the application for renewal in<br>good time before the expiry of the time limit. If an<br>application requires verification of personal suitability<br>and reliability for admission to a specialist training<br>course, the competent authority may waive a renewed<br>verification if the certificate for participation in the<br>specialist training course was issued no more than one<br>year ago. |
