Teaser	If you have successfully completed your training in Germany and are looking for a job that matches your qualifications, you can apply for a residence permit.
Volltext	If you have successfully completed school-based or company-based training, you may be granted a residence permit to look for a job. The residence permit will be issued for a maximum of 12 months directly following your previous training. This makes it possible for you to find a job appropriate to your qualifications. The aim of the search can also be self-employment. This residence permit allows you to work without restriction.
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Valid national passport</li> <li>• Proof of secure means of subsistence (e.g. training contract and payslips, bank statements, declaration of commitment by a third party)</li> <li>• Proof of health insurance</li> <li>• Proof of qualification (diploma, certificate or certificate from the training company/chamber confirming successful completion of vocational</li> </ul>

Voraussetzungen	<p>You have successfully completed qualified vocational training in Germany and have a valid residence permit for the purpose of vocational training (§ 16a AufenthG). Further general requirements for obtaining a residence permit are</p> <ul style="list-style-type: none"> <li>• a secure livelihood,</li> <li>• a clarified identity,</li> <li>• possession of a valid national passport.</li> </ul>
Kosten	Fixed costs: fee EUR 98.00
Verfahrensablauf	<p>You can only apply for a residence permit in person at the foreigners authority responsible for your place of residence.</p> <ul style="list-style-type: none"> <li>• You must submit the required documents in the original and pay the application fee.</li> <li>• The Foreigners' Registration Office will check whether the requirements for issuing the permit have been met.</li> <li>• If all requirements are met, the immigration authority will take your biometric data (photo, fingerprints) and order the electronic residence permit (eAT) from Bundesdruckerei GmbH.</li> <li>• As soon as the eAT is ready, it will be issued to you by the Foreigners' Registration Office.</li> </ul>
Bearbeitungsdauer	The processing time may vary in the local immigration authorities (about 5 to 6 weeks).
Frist	<p>Application before the current residence permit expires. It is recommended that you apply 4 to 6 weeks before your current residence permit expires.</p> <p>Application deadline 4 weeks</p>
