Teaser	If you have successfully completed your training in Germany and are looking for a job that matches your qualifications, you can apply for a residence permit.
Volltext	If you have successfully completed school-based or company-based training, you may be granted a residence permit to look for a job. The residence permit will be issued for a maximum of 12 months directly following your previous training. This makes it possible for you to find a job appropriate to your qualifications. The aim of the search can also be self-employment. This residence permit allows you to work without restriction.

Voraussetzungen	You have successfully completed qualified vocational training in Germany and have a valid residence permit for the purpose of vocational training (§ 16a AufenthG). Further general requirements for obtaining a residence permit are
	 a secure livelihood, a clarified identity, possession of a valid national passport.
Kosten	Fixed costs: fee EUR 98.00
Verfahrensablauf	 You can only apply for a residence permit in person at the foreigners authority responsible for your place of residence. You must submit the required documents in the original and pay the application fee. The Foreigners' Registration Office will check whether the requirements for issuing the permit have been met. If all requirements are met, the immigration authority will take your biometric data (photo, fingerprints) and order the electronic residence permit (eAT) from Bundesdruckerei GmbH. As soon as the eAT is ready, it will be issued to you by the Foreigners' Registration Office.
Bearbeitungsdauer	The processing time may vary in the local immigration authorities (about 5 to 6 weeks).
Frist	Application before the current residence permit expires. It is recommended that you apply 4 to 6 weeks before your current residence permit expires. Application deadline 4 weeks
