Teaser	Anyone wishing to offer low-threshold care services for people in need of care must first have them recognized. The application for recognition of services in accordance with § 45a SGB XI is made individually in the federal state in which the service is provided.
Volltext	<p>Low-threshold offers for support in everyday life (care and relief offers) are offers according to § 45a para. 1 SGB XI, in which helpers under professional guidance</p> <ul style="list-style-type: none"> <li>• take over the care of the beneficiaries in groups or individually in the home,</li> <li>• support the beneficiary in the home - especially with household chores,</li> <li>• accompany the beneficiaries in coping with general or care-related requirements of everyday life,</li> <li>• support the beneficiaries in organizing individually required assistance on their own responsibility,</li> <li>• relieve the burden on relatives or persons similarly close to them in their capacity as caregivers and provide them with advisory support.</li> </ul> <p>If you want to offer a support service in everyday life, you need to be recognized by the state. Each federal state has a competent authority that is responsible for the recognition procedure.</p> <p>You can find more detailed information on the corresponding homepage of the federal states.</p>
