	<ul style="list-style-type: none"> • the focus must be on living together and integration into society, • the Housing and Care Act applies, • the scope of care must largely correspond to care in a fully inpatient facility. <p>If you claim pro rata care allowance for the days on which you are cared for and looked after at home, the days of arrival and departure are regarded as full days of care at home.</p>
