| Teaser                        | If you take part in "accompanied driving from 17", you can drive a vehicle of categories B and BE in Germany before your 18th birthday under certain conditions. In this case, you must always be accompanied by a previously appointed and suitable person.   |
| Volltext                      | <p>In Germany, you can drive a vehicle in categories B and BE (passenger cars) at the age of 17 if</p> <ul style="list-style-type: none"> <li>• you have passed the driving test and</li> <li>• you are accompanied by an authorized and previously named person.</li> </ul> <p>On the date of your 18th birthday, you may drive the vehicle unaccompanied.</p> <p>However, if you drive a vehicle before your 18th birthday without being accompanied by a named person, your driving license will be revoked.</p> <ul style="list-style-type: none"> <li>• a fine,</li> <li>• a point on the driving aptitude register,</li> <li>• the extension of the probationary period and</li> <li>• an order for an advanced training seminar.</li> </ul> |

| Frist                        | An application may be submitted at the earliest six months before the age of 17.   |

| Hinweise                     | If a BF 17 participant drives a motor vehicle without being accompanied by a named person, the driving license must be revoked. In addition, there is a fine, a point in the driving aptitude register, an extension of the probationary period and an order for an advanced training seminar.   |

| Kurztext          | <ul style="list-style-type: none"> <li>• First-time issue of a driving license for accompanied driving from the age of 17 for category B</li> <li>• By participating in "accompanied driving from 17", the minimum age for obtaining a category B and BE driving license is lowered to 17.</li> <li>• If a person takes part in "accompanied driving from 17" and passes the driving test, they first receive a test certificate.</li> <li>• With the test certificate, the person may drive a vehicle of categories B and BE in Germany before their 18th birthday accompanied by a named and authorized person.</li> <li>• Responsible: competent driving license authority</li> </ul> |
