Teaser	If the electoral roll for the European election contains incorrect information, you can have it corrected.
Volltext	If the electoral roll for the European election contains incorrect information or is incomplete, you can have this corrected. From the 20th day before the election (= start of the inspection period), this is only possible following an objection or ex officio. The objection is only possible until the 16th day before the election (= end of the inspection period). It must be submitted in writing or recorded in writing to the municipality of residence. The municipality shall decide on the objection by the 10th day before the election. An appeal against the decision may be lodged within two days of notification. The municipality may correct the electoral roll at any time if it is obviously incorrect or incomplete. The electoral roll shall be closed no later than the day before the election.
Erforderliche Unterlagen	conclusive documents proving the need for correction in the electoral roll or, in the absence of an entry, proof of eligibility to vote

Verfahrensablauf	<p>Have the electoral roll for the European election corrected as follows:</p> <ul style="list-style-type: none"> <li>• After inspection, you discover an error in the electoral roll or you are not registered although you are entitled to vote.</li> <li>• You file an objection and substantiate the facts with suitable evidence.</li> <li>• The authority corrects the electoral roll or sends a rejection notice. In the event of subsequent registration, you will receive a notification of election.</li> </ul>

Kurztext	<ul style="list-style-type: none"> <li>• Electoral roll for the European election Correction</li> <li>• from the 20th day before the election - beginning of the period for inspection - the electoral roll can only be corrected upon objection or ex officio</li> <li>• Objection is only possible until the 16th day before the election (= end of the period for inspection)</li> <li>• Objection must be made in writing or in writing.</li> <li>• Decision of the municipality on objection at the latest 10 days before the election</li> <li>• possibility of appeal against this within two days after delivery</li> <li>• obvious mistakes, which are not the subject of an objection, can be corrected by the municipality ex officio.</li> <li>• completion of the electoral roll no later than the day before the election</li> </ul>
