No documents are required for the initial consultation. You will find out which documents will be required in the course of the consultation at your consultation appointment.

Voraussetzungen

There are no special requirements for the counseling. Counseling is possible, for example, even if you have not yet applied for asylum. The prerequisite for financial support is one of the following:

- You are in the asylum procedure.
- Your asylum application has been rejected and you are obliged to leave the country.

If the decision on the application is positive, you organize the return journey and arrival in your home country together with your advisor.
