Volltext	All persons entitled to vote have the right to inspect the electoral roll on the working days from the 20th to the 16th day before the election, during the general opening hours at the municipal electoral authority, in order to check the correctness and completeness of the data entered about their person. The application for correction of the electoral roll must be submitted in writing to the municipal electoral authority by the 16th day before the election, stating surname, first name, date of birth and residential address.

Verfahrensablauf	The application for correction of the electoral roll must be submitted in writing to the municipal electoral authority by the 16th day before the election, stating the surname, first name, date of birth and residential address.

Frist	Inspection may be granted from the 20th to the 16th day before the election. The written request for correction must be submitted to the municipal electoral authority by the 16th day before the election.
