Teaser	You may have a legitimate interest in obtaining information from the register of owners of a business in an unlicensed craft or a craft-like trade. You can obtain this information from the relevant Chamber of Crafts.
Volltext	<p>The Register of Owners of a Business of an Admission-Free Craft or Craft-like Trade is a register of all owners of a standing trade in which admission-free craft or craft-like trade activities are carried out. It is kept by each chamber of commerce for its chamber of commerce district.</p> <p>Information from the register can be provided upon request if you can prove a legitimate interest.</p> <p>AnInformation from the Register of Skilled Crafts contains the following information about a company:</p> <ul style="list-style-type: none"> <li>• Company details</li> <li>• First name and surname of the registered owner/tradesman, or of the legal representative or of the company manager or of the personally liable partner responsible for the technical management of the company</li> <li>• Type of registered craft</li> <li>• Address of the commercial establishment.</li> </ul>

	<p>Provided that no interest of the data subject worthy of protection speaks against it, the information will be made available to you. As the recipient of the information, however, you may only use this data for the purpose you specified when submitting the application.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Application for individual information from the register of skilled crafts (according to § 6 para. 2 HwO)</li> </ul> <p>The application must contain</p> <ul style="list-style-type: none"> <li>• Information on the applicant for the information</li> <li>• details of the business (address, name) for which information is requested</li> <li>• Information on the legitimate interest of the applicant</li> <li>• Personal document Identity card or passport with registration confirmation or residence permit or other comparable personal documents</li> </ul>
Voraussetzungen	<ul style="list-style-type: none"> <li>• Legitimate interest</li> </ul> <p>You may have a legitimate interest if you are pursuing a commercial goal with the information, for example if you are a supplier who wants to know who owns a craft business. As a private individual, you can also invoke legitimate interest if you want to know more about a business.</p>
Kosten	<ul style="list-style-type: none"> <li>• The costs are based on the fee schedule of the responsible Chamber of Crafts.</li> <li>• Fees will also be charged if the craft enterprise sought could not be identified (negative information).</li> </ul>
Verfahrensablauf	<ul style="list-style-type: none"> <li>• You submit an application to the responsible Chamber of Crafts for information from the register of owners of a business in an unlicensed craft or a craft-like trade. In your application, you name the business for which you want information and state your legitimate interest.</li> <li>• After examining the legitimate interest, the Chamber of Crafts will provide the information.</li> <li>• Provided that there is no interest worthy of protection of the person concerned against it, the information will be provided to you. However, you may only use this data for the purpose you specified when</li> </ul>

Kurztext	<ul style="list-style-type: none"> <li>• Register of owners of a business of an unlicensed craft or a craft-like trade - information.</li> <li>• Anyone with a legitimate interest can request information.</li> <li>• A legitimate interest is anyone who pursues an economic goal with the information (for example, suppliers or clients).</li> <li>• After examination of the request by the Chamber of Crafts, the information will be provided, unless there is a legitimate interest of the person concerned.</li> <li>• Competent authority: Chamber of Skilled Crafts in whose district the head office of the skilled crafts enterprise is located.</li> </ul>
