Teaser	You would like to give up your position as an authorized district chimney sweep? To do so, you must contact the competent authority. You can find out more here.
Volltext	If an authorized district chimney sweep wishes to give up his or her job, this administrative act must be cancelled by the competent authority. The district chimney sweep must then apply for deletion from the register of craftsmen and, if necessary, deregister his trade if the entire activity is to be discontinued.

Kosten	<p>are based on the respective administrative fee schedule of the state or on the fee schedules of the bodies responsible under state law.</p> <p>In addition, in order to clarify whether the requirements of Section 12 (2) SchfHwG are met, the competent authority may request the authorized district chimney sweep to submit a medical report on his state of health at his own expense if there are demonstrable signs of a physical infirmity or a weakness in his physical or mental strength.</p>
Verfahrensablauf	<p>Once you have submitted the application and all the documents are complete, the competent authority will check whether you meet all the requirements.</p> <p>If you meet all the requirements, the competent authority will issue a notice releasing you from the post of authorized district chimney sweep.</p> <p>The competent authority must immediately notify the Federal Office of Economics and Export Control of the cancellation of the appointment for the purpose of maintaining the chimney sweep register by the competent authority.</p>
