Teaser	In the event of changes such as a change of name due to marriage, registered civil partnership, divorce, dissolution of a civil partnership or other data, the passport must be amended or reissued.
Volltext	The data in your passport must always be up to date. If certain changes occur, you must apply for a new passport. Voraussetzungen	The following changes must be made in order to apply for a change of passport: • Change of name on marriage or establishment of a civil partnership • Change of name in the event of divorce or dissolution of a civil partnership • Change of other data
Kosten	• up to 24 years (valid for 6 years): EUR 37.50 • from 24 years (validity 10 years): 60.00 EUR Further fees are set out in § 15 of the Passport Ordinance (PassV).
Verfahrensablauf	You must apply for changes to your passport in person at your passport authority. Once the passport has been produced, it will be sent by the passport manufacturer to the passport authority where you applied. You can then collect the passport there.

Frist	A new passport issued as a result of changes is valid for • for applicants under the age of 24: 6 years • for applicants aged 24 and over: 10 years • temporary passport: maximum 1 year The validity of the passport cannot be extended.
