Volltext	If you would like to hunt in Germany but are not yet 18 years old, you can only be issued a youth hunting license in your name. If you already have a hunting license but its validity has expired, you can apply for an extension.

Voraussetzungen	• at least 16 and not yet 18 years old at the time of issue • personal reliability • physical fitness • completed hunting liability insurance • Youth hunting license already issued • consent of the legal guardian

Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, complete it and submit it by post or in person to the competent authority.

	The application and the evidence to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued a youth hunting license.
Bearbeitungsdauer	
Frist	The daily hunting license is valid for 14 consecutive days.
weiterführende Informationen	
Hinweise	The youth hunting license only entitles the holder to hunt in the company of a person with parental authority or a supervisor appointed in writing by the person with parental authority; the accompanying person must be experienced in hunting. The youth hunting license does not entitle the holder to participate in group hunts.

Kurztext	• Youth hunting license New issue of day hunting license • required for hunting in Germany • Persons who already hold or have held a German hunting license • if validity has expired or will expire, then hunting license must be renewed if hunting is to be continued • for persons under 18 years of age, minimum age 16 years • must be accompanied by a legal guardian or authorized representative with hunting experience • No participation in social hunting • is valid for 14 consecutive days • Responsible: lower hunting authority
