Teaser	If you want to discharge commercial/industrial wastewater into a public wastewater system or sewer system, you usually need a permit. Until the permit is issued, the authority may allow you to discharge the wastewater beforehand.
Volltext	If you wish to discharge wastewater into a public wastewater system, you must apply for a permit. If you cannot or do not want to wait until the permit is issued, the competent authority may permit an early start of the discharge. You must apply for this.
Erforderliche Unterlagen	• Application for early start for discharging wastewater into public wastewater systems • If applicable, documents, such as statements, justifying your interest in the early start
Voraussetzungen	Approval is granted if • an application for approval has already been submitted • a decision in favor of the applicant can be expected, • there is a public interest or a justified interest of the applicant in the premature commencement, • and the applicant undertakes to compensate for all damage caused by the discharge until the decision is made and, if the discharge is not approved, to restore it to its former condition.

Verfahrensablauf	• You submit an application for approval of the

discharge of wastewater into a public wastewater system - early start to the agency responsible for the approval.

- They will examine your application and the justified personal or public interest in an early start of the wastewater discharge.
- You submit any requested documents.
- You agree to compensate for all damage caused by the discharge until the decision is made and, if the discharge is not approved, to restore it to its previous condition.
- The responsible agency approves the early start of the wastewater discharge.
- You will receive an approval notice from the competent body and, if applicable, a fee invoice.
- You pay the fee invoice, if applicable.
- You can start the premature discharge of wastewater into a public wastewater system.

Bearbeitungsdauer

The processing time depends on the quality and volume of the submitted applications, the submitted documents as well as on the procedure to be carried out and the processing status of the permit application.

- Discharge of wastewater into public wastewater systems early start permit
 - upon application, the discharge of wastewater into a public wastewater system may be started before the permit is issued
 - a permit must already have been applied for
 - it must be expected that the discharge will be approved
 - there must be a public or legitimate interest on the part of the applicant
