Teaser	You want to erect a temporary structure for an event. To do so, you must notify the lower building supervisory authority at the installation site.
Volltext	If you wish to erect a temporary structure that requires a building permit for an event, you must notify the lower building supervisory authority at the place of erection. Temporary structures are structures that are suitable and intended to be set up and dismantled repeatedly. Examples include merry-go-rounds, air swings, Ferris wheels, roller coasters and slides, grandstands, stalls, tents and structures for aerial performances, as well as stages and canopies for cabarets and concerts.
Erforderliche Unterlagen	• Completed notification • inspection book • Site plan (in the development plan) • If applicable, a declaration on the assumption of costs in the event of a necessary acceptance of use
Voraussetzungen	• You must present a valid work permit. The execution permit is noted in the inspection logbook.
Kosten	• Display: free of charge • if an acceptance of use is necessary: the acceptance of use is subject to a charge. The specific cost framework can be found in the service description of the acceptance of use.

Verfahrensablauf	The building permit may stipulate that notification is not required because a risk to life and health is not to be expected. If notification is required, submit the notification and other necessary documents to the lower building supervisory authority at the installation site. The lower building supervisory authority will check the notification and If a temporary structure is to be erected in one place for longer than three months, a subsequent inspection may be carried out by the lower building supervisory authority.
