| Teaser                   | Referendum is the means of putting a bill from a referendum petition to a vote after it has been rejected by the state parliament.   |
| Volltext                 | If the Landtag does not adopt the bill of a successful<br>referendum petition essentially unchanged within six<br>months, a referendum shall be held. A bill is adopted<br>by referendum if the majority of those voting, but at<br>least a quarter of those eligible to vote, have approved<br>it.  |
| Erforderliche Unterlagen |  |
| Voraussetzungen          | A referendum shall only be held if Parliament rejects a<br>bill submitted by referendum petition or if it fails to<br>meet the deadline under section 16(3) VaG. The<br>referendum on the bill shall then take place within<br>three to six months of the decision to reject it or the<br>expiry of the deadline.  |
| Kosten                   | The costs of the referendum shall be borne by the state.   |
| Verfahrensablauf         | The referendum shall be held no earlier than three<br>months and no later than six months after the decision<br>to reject the bill or the expiry of the deadline. The state<br>government shall set the day of the referendum on a<br>Sunday or public holiday and shall announce it in the<br>official gazette for Mecklenburg-Western Pomerania<br>together with the subject matter of the referendum,<br>which shall include, in addition to an explanation of the<br>previous and further procedure, the draft bill with<br>reasons. The announcement enables the state<br>government and the state parliament to present their<br>views on the draft law in a concise and factual form.<br>The referendum is held in the municipalities. A register<br>of voters shall be drawn up on the eligibility to vote.<br>Voting shall take place between 8:00 a.m. and 6:00 p.m.<br>in a room accessible to the public, which shall be such<br>as to preserve the secrecy of the ballot. |                                 | election administration may, if special reasons so<br>require, extend the voting time. Voting shall be<br>general, direct, free, equal and secret. The voters shall<br>indicate by a cross on the ballot paper whether they<br>wish to answer the question posed with "yes" or "no"<br>or which of the bills, the contents of which are<br>incompatible, they wish to vote for. The content of the<br>question shall be determined by the state election<br>administration.                    |
|                                 | A bill shall be adopted by referendum if the majority of<br>those who cast their votes, but at least a quarter of<br>those entitled to vote, have approved it. If the number<br>of valid yes and no votes is equal, the bill is rejected. In<br>the case of a constitutional amendment, two-thirds of<br>all those voting and at least half of all those entitled to<br>vote must have voted in favor. The result of the<br>referendum shall be determined by the Land Electoral<br>Committee. |

| Frist                           | The referendum shall be held at the earliest three<br>months and at the latest six months after the decision<br>to reject the referendum petition or after the<br>six-month period has expired without results.  |
