Teaser	If you want to host online poker, you can apply for a permit under certain conditions. The permit can be applied for online or in writing.
Volltext	You can apply for a permit to organize online poker. You may only organize online poker games in Germany with a valid permit. The permit procedure includes a main application for the general permit. Applicants can be the organizing persons themselves or authorized persons (internal persons of a company or external persons, for example lawyers).

- Information on the addictive risks of the online poker games offered, the prohibition of participation by minors, and the counseling and therapy options available to them
- Communication of the probable amount of the play stakes in the Federal Republic of Germany of the next 5 years
- Representation of the measures for the prevention of manipulations
- Printout of the General Terms and Conditions (GTC) for online poker on the Internet
- Declaration of auditor or certified public accountant regarding the company's ability to perform its duties
- Declaration of tax advisor or tax consultant, legal advisor or legal consultant, declaration of certified public accountant or certified public accountant on performance capability

Voraussetzungen

You must be at least 18 years of age. You must be domiciled in a member state of the European Union or a state party to the Agreement on the European Economic Area in order to apply for permission to organize virtual slot machine games in Germany.

In addition, you must meet the requirements of the State Gambling Treaty of 2021:

- Extended reliability (no unlicensed gambling, transparent ownership and shareholding relationships).
- Performance (sufficient own funds, profitability, insurance coverage)
- Transparency and security of gambling

Verfahrensablauf

You can apply for permission to conduct online poker both online and in writing. If you want to apply for permission to conduct online poker in writing:

- In the first step, process the "main application".
- In the main application, you provide information about the organizer, all authorized representatives and other responsible persons. Furthermore, you have to provide information about the reliability of the organizer and information about the distribution and the handling.
- You must have fully processed your application before submitting it. It is permissible for required documents to be submitted subsequently if they were not yet available when the application was submitted. However, the competent authority can only process applications finally if all documents have been submitted.
- In the course of the application processing by the competent authority, you must ensure the provision of a security deposit in the amount of at least EUR 5 million up to a maximum of EUR 50 million.
- After you have submitted the main application, you must submit a downstream application for the individual virtual slot machine games. In doing so, provide information on the technical access to the virtual slot games as well as all details (name, type, URL, category and the game rules). The downstream application can be submitted by you immediately after the main application, but no later than two weeks after the granting of permission related to the main application.
- After completion of the review and approval by the Joint Gambling Authority of the Federal States (GGL), you will receive a permit notice by mail.

If you wish to apply online:

- Create a company/citizen account online.
- In this case, you will receive the permit notice directly via your service account.
- Communication with GGL also works via your service account.
- The remaining steps are identical to the written
