Teaser	If you, as a hunting association, have a firearms possession card (WBK) and wish to purchase a firearm requiring a permit, you must apply for this.
Volltext	If you, as a hunting association, have a gun ownership card (WBK) and wish to purchase a firearm requiring a permit, you must apply for this. The permit is granted by the competent authority by means of an entry in the gun ownership card (pre-entry). With the pre-entry, you have one year to acquire the registered firearm. In the application for a permit to purchase a firearm, you only need to state what type of firearm and caliber you wish to purchase. Further details, such as the manufacturer and exact model, are not initially required. You only have to provide this information

	once you have acquired the weapon and have fulfilled your obligation to notify the competent authority of the acquisition of the weapon. The gun dealer must also report the transfer of the weapon to you. You must prove that you can safely store the weapon you wish to purchase.

Hinweise	To complete the application more quickly, you can use the NWR identification numbers (NWR ID): • your personal NWR ID (P or F NWR ID) for your personal details • the permit NWR ID for the firearms permit (E-NWR ID) • the weapon or weapon part NWR ID (W or T NWR ID). You can obtain the NWR IDs on application to the relevant weapons authority.

Sachverhalt

- Purchase of a weapon requiring a permit must be applied for (purchase authorization)
 - Pre-registration authorizes the purchase of a weapon requiring a permit; without pre-registration, the weapon dealer may not sell the weapon
 - For pre-registration, specification of type of weapon and caliber sufficient, not exact model
 - Pre-registration is valid for 1 year; weapon can be purchased within this period
 - Prerequisite: Weapon possession card (WBK) for clubs
 - Acquisition of the weapon must be reported to the responsible weapons authority within two weeks; the weapons dealer must also report the acquisition
 - Responsible: Weapons authority
