Voraussetzungen	<p>There must be good cause.</p> <p>Good cause exists in particular if:</p> <ul style="list-style-type: none"> • there is a conflict between the pawnbroker's obligations under the Pawnbroker Ordinance and other legal provisions, • a postponement of the realization is in the interest of the pledger, for example if, for seasonal reasons, a more favorable result can be achieved for the pledger in a later realization despite the interest and costs that continue to accrue,
