Verfahrensablauf	You can notify the ARD, ZDF and Deutschlandradio Contribution Service of contribution-relevant increases in writing by mail or by telephone. You must report contribution-relevant reductions in writing by mail with supporting documents. In writing by mail: • You open the PDF change form, fill it out, print it out and sign it. • Then send it by mail to the contribution service. • For dues-related reductions, also attach the appropriate supporting documentation. By telephone: • Call the Contribution Service telephone hotline and go through the document with a contact person.
