Teaser	If you wish to put a fireplace, combustion engine or combined heat and power unit into operation, you must first apply for a certificate of suitability and safe usability of the flue gas systems.

	You must apply for the certificate from the authorized district chimney sweep. He will then check the suitability and safe usability of the flue gas systems on site and issue you with a certificate.
	In the case of planned commissioning of combustion engines and combined heat and power units, the authorized district chimney sweep will check the suitability and safe usability of the pipes for

	discharging combustion gases and issue you with a certificate. You must give the authorized district chimney sweep the opportunity to inspect the shell of the building in good time.
Erforderliche Unterlagen	Informal application
Voraussetzungen	 You must be the building owner. You have already notified the building supervisory authority of the planned commissioning of the fireplaces, combustion engine or combined heat and power plant in good time.
Kosten	Cost range: from 37.19 euros to 85.68 euros
	 The fee for the required preliminary inspection of the building shell is 37.19 euros. The fee for issuing the certificate is 85.68 euros. There is an additional fee of 1.43 euros per full meter or part thereof of the vertical part of the chimney or flue gas pipe. In addition, there is a travel fee of 0.86 euros for each kilometer traveled in the sweeping district.
Verfahrensablauf	If you wish to put a fireplace, combustion engine or combined heat and power unit into operation, you must apply for a certificate of suitability and safe usability in advance.
	To do this, submit an informal application to the authorized district chimney sweep responsible for you.
	The authorized district chimney sweep will then inspect and test your fireplace, combustion engine or combined heat and power unit on site. Following the inspection and test, the authorized district chimney sweep will issue you with a certificate of suitability and safe usability.
	If the authorized district chimney sweep finds any defects, you will receive a defect report. Only after you have rectified the defects will you receive the certificate of suitability and safe usability.
