Teaser	Do you want to use a system for the application of non-ionizing radiation to humans, for cosmetic or other non-medical purposes? Then you must notify the competent authority of this equipment at least two weeks before commissioning.
Volltext	<p>The Ordinance on Protection against Harmful Effects of Non-Ionizing Radiation when Used on Humans (NiSV) regulates the commercial operation of laser devices, intense light sources, high-frequency devices, electrical nerve and muscle stimulation devices, magnetic field stimulation devices, central nervous system stimulation devices and ultrasound devices.</p> <p>Anyone using these devices commercially for cosmetic and other non-medical purposes has had to meet new operating requirements as well as documentation and consultation obligations since the start of 2021. In addition, the operation of devices used must be reported to the competent authority. The operation of the respective device must be reported to the competent authority at least two weeks before commissioning.</p> <p>Some applications may only be carried out by licensed doctors with appropriate further training and</p>
