Verfahrensablauf	You must register in writing for the state examination as a child and adolescent psychotherapist. To do so, use the prescribed form or, if available, the online application. Submit your application with the required documents to the relevant office.
Bearbeitungsdauer	
Frist	bis 10.05.2024 in the summer semester bis 10.12.2024 in the winter semester The application must be received by the responsible office by December 10 in a winter semester or by May 10 in a summer semester. It can be submitted at the earliest six months before the next examination date, but not before the last semester of the Master's degree program.
