Teaser	If you manufacture, handle, store, transport or place feed on the market, you must register your business and all associated business premises as a feed business.
Volltext	According to EU law, every feed business operator must register all establishments under its control (every installation of a feed business) that are active in one of the production, processing, storage, transportation or distribution stages of feed. The notification must be made in writing or electronically in the form required by the competent authority.
Erforderliche Unterlagen	Apart from the information on the application form, no other documents are required for registration.
Voraussetzungen	Registration requires information on the company and its activities as per the application form.
Kosten	Verwaltungsgebühr: 490€ - 1.230€ for registration in accordance with Section 21 of the

	Feedstuffs Ordinance, per establishment Registration in accordance with Regulation (EC) No. 183/2005 is free of charge.
Verfahrensablauf	You can apply for registration in writing or electronically. You complete the application and send it by e-mail or post to the competent feed monitoring authority. The competent feed monitoring authority will check your application and record your farm data. Registration in accordance with Regulation (EC) No. 183/2005 will only be confirmed on request. Registration in accordance with the Feedstuffs Regulation will be decided by official notification.
