Teaser	If you wish to manufacture, process or repair firearms or ammunition on a commercial basis, you require a firearms manufacturing license.
Volltext	You require a firearms manufacturing license for the commercial or independent manufacture, processing or repair of firearms or ammunition. You can obtain this from the weapons authority responsible for your place of business. It can be restricted to certain types of firearms and ammunition. The permit is only issued for a natural person (sole proprietorship). In the case of legal entities, the responsible managing director or the personally liable partner each require their own permit. If the gun manufacturing business is to be operated by a deputy or if a person is to be appointed to manage a branch office or a dependent branch office, you will require a deputy license. You can also apply for this from the relevant firearms authority. Deputies receive this permit under the same conditions. These requirements include, among other things, proof • age of majority, • reliability, • personal suitability and • specialist knowledge.

	Your permit will lose its validity if you have not started the activity within one year of the permit being issued or if you have not exercised it for one year. The deadlines can be extended for special reasons.
Erforderliche Unterlagen	Certificate of successful completion of a master gunsmith examination or exemption permit Proof of safe storage of weapons and ammunition Floor plan of the premises Site plan of the premises Notice of rejection or permit in the case of a previous application for a permit to manufacture weapons
Voraussetzungen	You are of legal age and have the necessary reliability, personal suitability and specialist knowledge.
Kosten	The costs are based on the cost ordinance for official acts in the field of weapons manufacturing law in Mecklenburg-Vorpommern, which came into force on 01.02.2017. According to tariff item 100.1, the fee for the weapons manufacturing permit is 107 to 3,000 euros
Verfahrensablauf	The firearms authority responsible for the place of business in the districts / independent cities in M-V is responsible.
Bearbeitungsdauer	If all the necessary requirements are met, a processing time of 3 months should be sufficient.
Frist	10 Jahr(e) If all the necessary requirements are met, a processing time of 3 months should be sufficient.
