Volltext	If you wish to use the professional title of restorer in Mecklenburg-Vorpommern, you must be entered in the list of restorers of the state of Mecklenburg-Vorpommern. The list of restorers is published in the official gazette of the state of Mecklenburg-Vorpommern. Your contact details and your specialty will be listed there. This does not affect the title of restorer in the trade.

Voraussetzungen	- You must have a university degree as a restorer. - If there is no university degree in the relevant field at a German university, you must have been working as a conservator in the relevant field for 7 years. You must also provide evidence of your expertise in the form of two approving expert reports drawn up by two recognized restorers from the specialist field or the closest related specialist field. - You must be resident in Mecklenburg-Vorpommern or have your professional focus in Mecklenburg-Vorpommern.
Kosten	Gebühr: 56,25€ if the application is rejected. Gebühr: 75€ for entry in the list of restorers
Verfahrensablauf	1. Application: You submit an application with the required documents. 2. Assessment: An expert commission assesses your application and checks its eligibility for registration. 3. Decision: You will receive a decision on your application. 4. Publication: The current list of restorers is published in the official gazette.
